

Suggested Prescribing Resources



Requirements

The Board of Licensure in Medicine, The Board of Osteopathic Licensure, and the Board of Nursing for Maine all <u>require 3 hours of training regarding opioid prescribing every two years.</u>

The Federal DEA has a one-time requirement of all prescribers to attest to having eight hours of training regarding opioid prescribing. This occurs at either an initial application for DEA registration or when you renew your DEA registration after June 27, 2023. There are several ways this can be satisfied:



Establish Baseline

The following groups of practitioners are deemed to have satisfied this training:

Group 1: All practitioners that are board certified in addiction medicine or addiction psychiatry from the American Board of Medical Specialties, the American Board of Addiction Medicine, or the American Osteopathic Association.

Group 2: All practitioners that graduated in good standing from a medical (allopathic or osteopathic), dental, physician assistant, or advanced practice nursing school in the United States within five years of June 27, 2023, and successfully completed a comprehensive curriculum that included at least eight hours of training on:

Treating and managing patients with opioid or other substance use disorders, including the appropriate clinical use of all drugs approved by the Food and Drug Administration for the treatment of a substance use disorder; or Safe pharmacological management of dental pain and screening, brief intervention, and referral for appropriate treatment of patients with or at risk of developing opioid and other substance use disorders.

Practitioners can satisfy this training by engaging in a total of eight hours of training on treatment and management of patients with opioid or other substance use disorders from the groups listed below. A few key points related to this training:

- 1. The training does not have to occur in one session. It can be cumulative across multiple sessions that equal eight hours of training.
- 2.Past trainings on the treatment and management of patients with opioid or other substance use disorders can count towards a practitioner meeting this requirement. In other words, if you received a relevant training from one of the groups listed below— prior to the enactment of this new training obligation on December 29, 2022—that training counts towards the eight-hour requirement.
- 3. Past DATA-Waived trainings count towards a DEA registrant's 8-hour training requirement.
- 4. Trainings can occur in a variety of formats, including classroom settings, seminars at professional society meetings, or virtual offerings.











What accredited groups may provide trainings that meet this new requirement?

- The American Society of Addiction Medicine (ASAM)
- The American Academy of Addiction Psychiatry (AAAP)
- American Medical Association (AMA)
- The American Osteopathic Association (AOA), or any organizations accredited by the AOA to provide continuing medical education
- The American Dental Association (ADA)
- The American Association of Oral and Maxillofacial Surgeons (AAOMS)
- The American Psychiatric Association (APA)
- The American Association of Nurse Practitioners (AANP)

- The American Academy of Physician Associates (AAPA)
- The American Nurses Credentialing Center (ANCC)
- Any other organization accredited by the Accreditation Council for Continuing Medical Education (AACCME) or the Commission for Continuing Education Provider Recognition (CCEPR), whether directly or through an organization accredited by a State medical society that is recognized by the ACCME or CCEPR
- Any other organization approved or accredited by the Assistant Secretary for Mental Health and Substance Use, The ACCME, or the CCEPR

Maine Independent Clinical Information Service (micismaine.org). The Maine Independent Clinical Information Service (MICIS), a program of the Maine Medical Association, has 2 hours of live private/individual opioid CME. The first is a review of Maine laws and rules, the CDC Guideline and Universal Precautions, and is great for new graduates or those new to Maine. The second is on diagnosing and treating OUD. Free to prescribers or health profession students in Maine. Funded by Maine DHHS.

<u>Substance Use Disorder Online CME | AAFP</u> This is open to AAFP members for free.
